Designated as an Area Agency on Aging in 1974, the Area Agency on Aging of Northwest Michigan is a private, non-profit 501(c)3 organization.

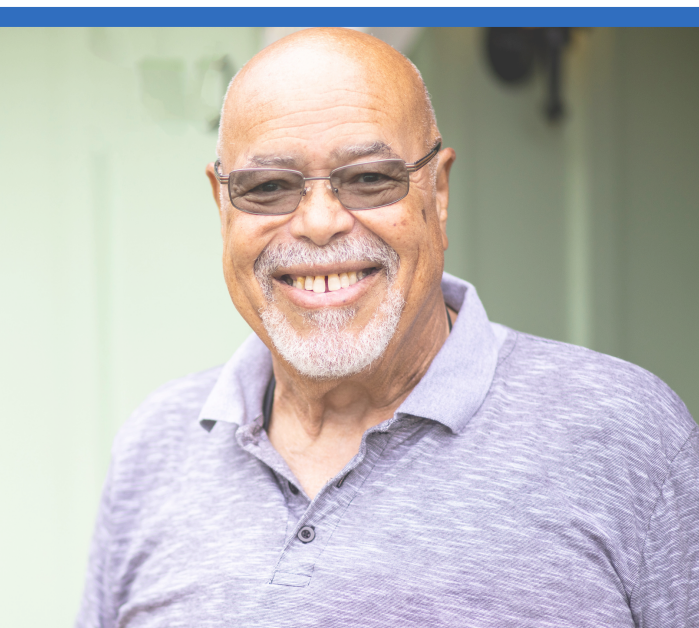

Information and Referral

Connects older adults, family members and caregivers with a wide range of resources and services to support aging needs. Caring and trained Access and Eligibility Specialists are available by telephone, telehealth and e-mail.

Options Counseling

Offers unbiased support to discuss complex aging needs, explore options for assistance, and create a plan. We help you identify long term care needs and options while also helping you understand healthcare decisions, care settings and end of life planning.

Caregiver Support

Supports individuals experiencing caregiving challenges and stress, and with proactive planning for future needs such as housing, finances, healthcare decision making and long term care.



Care Management Program

Empowers individuals to live at home rather than a nursing facility. Must be 60 years of age or older, have difficulties performing activities of daily living, and need assistance coordinating community resources. Experienced nurses and social workers help individuals identify personal needs and develop a plan of care.



MI Choice Medicaid Waiver Program

Provides eligible individuals with care and services to live in the community rather than a nursing facility. To qualify, one must be 18 years or older with a disability or age 65 or older, eligible for nursing home admission and qualify for Medicaid to pay for long term care.



Medicare/Medicaid Assistance

Provides unbiased counseling about health benefit plans including Medicare Part D drug plans. Our counselors are specialists trained in Medicare law and regulations and are not associated with any health plan.

Long Term Care Ombudsman

Advocates on your behalf when you have care concerns in a nursing facility or adult foster care home. We can also discuss alternative long term care options with you.
